Eligibility

1. The Lolly Jar Competition welcomes participation from all persons, excluding relatives of staff directly involved in administering the competition.
2. Each person is limited to submitting only one (1) entry, unless they are a parent/carer submitting an entry for a person under 18.
3. Persons aged under 18 can enter by submitting a guess, however this must be submitted with consent, and by a guardian/carer on their behalf.
4. By entering the competition, you affirm your eligibility to participate and claim any potential prize. BCE reserves the right to request proof of eligibility.
5. To enter, you must provide a valid email address which will be subscribed to the Holy Cross Alumni and Friends enewsletter mailing list for marketing purposes. The entrant can unsubscribe or opt-out at any time.

7. BCE retains full authority to disqualify any participant whose submission contradicts the essence or purpose of the competition.

Judging and notification

8. Entries in the competition will undergo evaluation by BCE staff with three winners chosen, based on the three guesses closest to the number of lollies in the jar.
9. In the event that multiple entries guess the number of lollies or submit the same guess that is closest to the exact number and is, therefore, eligible to win, these eligible entrants will be judged based on the time submission of their guess.
10. Prizes will be awarded as follows:
 - 1x \$100 Archie Bros. gift voucher for the closest guess
 - 1x \$50 EB Games gift voucher to the second-closest guess
 - 1x \$50 EB Games gift voucher to the third-closest guess
11. The winners will receive notification via the provided telephone number, and/or email address.
12. The prizes will be available for collection from Holy Cross Woolloowin at a mutually agreed-upon time and date, following confirmation of identity upon pick up.
